According to the University of Buffalo's Research Institute on Addictions, "some 19.2 million workers are impaired during the weekday from intoxication, withdrawal or hangover."

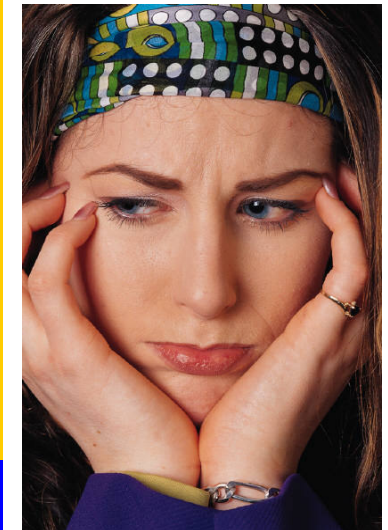
"One in five workers between the ages of 18 and 24 and one in eight between 26 and 35 have a substance abuse problem." (*National Institute on Drug Abuse*)
